

**"WIN\* 1 OF 2 \$250 VOUCHERS AND MURAL FEATURE"  
TERMS AND CONDITIONS**

These official rules ("Rules") apply to the "WIN\* 1 OF 2 \$250 VOUCHER AND THIS IS OUR LISMORE MURAL" ("Promotion") conducted by Shopping Centres Australasia (SCA Property Group) (ABN 47 158 809 851)

1. ) c/- CBRE Pty Ltd, Lismore Central Shopping Centre, 44 Carrington Street, Lismore NSW 2480 ("Promoter") for the Lismore Central ("Centre").
2. Information on how to enter forms part of these Rules. The Promoter may, at any time, amend, add to or delete any of these Rules.
3. Entry is deemed acceptance of these Rules including any changes made by the Promoter, even if the entry is before the publication of any changes to these Rules.
4. The Promotion commences at 9:00 am on Tuesday 16<sup>th</sup> October 2018 and ends at 12:00 pm on Monday 19<sup>th</sup> November 2018. ("Promotion Period").

**Eligibility**

5. To be eligible to enter the Promotion (and so be an "Entrant") an individual must be an Australian resident and make an Eligible Submission.

**Eligible Submission**

6. An "Eligible Submission" is a submission of a photograph:
  - (a) of any Lismore landmark, family photo:
    - (i) Photos must be taken by the entrant who assume full ownership of the photograph upon submitting the photo.
    - (j) Photo may be taken by a third party (ie photographer) however, the entrant must have full ownership of the photo prior to uploading
  - (b) Photos must not:
    - (i) Be uploaded without permission of any identifiable people within the photo; or
    - (ii) Depict rude, racist or explicit content deemed inappropriate by the promoter
  - (c) submitted during the Promotion Period.

**Entry**

7. An Entrant is entitled to upload multiple photos during the promotion period. Each photo is classified as an eligible submission
8. The Promoter has the right to refuse to accept a photo and to approve the submission if they believe that the photograph is not the property of the entrant.
9. To enter the Prize Draw and be eligible for the Prize, an Entrant must complete an Entry Form and lodge the completed Entry Form with a photograph to the upload point on the promoter's website during the Promotion Period.
10. To be a valid entry ("Valid Entry") the Entry Form must:
  - (a) be an original – photos copied from Google or similar (not the property of the entrant) will not be eligible to win the Prize;
11. On lodgment of a Valid Entry in accordance with these Rules, an Entrant will be eligible for the prize draw ("Prize Draw").

**Prizes**

15. The brand of goods constituting the Prize is at the sole discretion of the Promoter and is subject to availability.
16. The value of the Prize is accurate as at the commencement of the Promotion Period. The Promoter accepts no responsibility for any variation in the value of the Prize after that date. If for any reason the Prize is not available, the Promoter reserves the right to substitute another item for it, in its sole discretion, of equal or higher value.
17. The Prize ("Prize"), awarded by the Promoter must be redeemed by the ("Winner") through purchase of products from the requested Lismore Central Retailer no later than 12 months from the end of the promotion period.

**Prize Draw**

18. The Prize Draw will be conducted by the Promoter's customer representative drawing a photograph from a list on 19 November 2018.

**Drawing of Prizes**

19. The Entrant whose photo appears on the first Valid Entry randomly drawn during the Prize Draw will win a \$250 Voucher ("Winner").
20. The Entrants whose name appears on the second, Valid Entry forms randomly drawn during the Prize Draw will win a \$250 voucher ("Winner").
21. If a Valid Entry has two or more individuals' names recorded as the Entrant, the Winner will be the individual whose name appears first on the Valid Entry drawn.
22. The Winner will be notified after the Prize Draw by email and through the Lismore Central Facebook Page.
23. To be able to collect a Prize the Winner must provide a copy of a Government issued identification card containing a photograph of the Winner as proof of the Winner's identity.
24. If the Winner is under the age of 18 years, an adult guardian must accompany the Winner at the time of claiming the Prize. **General**

28. All eligible entrant photographs will be used at the promoter's discretion on 2 x Mural displays throughout the Centre
29. Entrants photographs will not be edited when being added into the Centre's Mural display
30. Entrants Eligible submissions will be credited to the entrant using details supplied at the submission point on the Centre website.
31. Eligible submission photos may be resized to fit within the specification of the mural (colour changes, cropping etc will not occur).
32. Photographs remain the property of the entrant, with the exception of the promoter having access to utilize the photos on the mural display as per the above and the promoter's discretion.
33. The Prize is not transferable or exchangeable and cannot be taken as cash.
34. In the event of war, terrorism, state of emergency or disaster, the Promoter reserves the right (subject to all relevant State and Federal laws), to cancel, terminate, modify or suspend the Promotion.
